The Situation

- August 2020 Lake Fire
 - ▶ 15 homes destroyed
- September 2020 Bobcat Fire
 - ▶ 87 homes destroyed
- Major Disaster Declaration
 - Authorize additional funding




Lake Fire

- August 12, 2020 September 28,
 2020 in the Angeles National Forest
- Impacted the communities of Juniper Hills, Valyermo and Pearblossom
- Over 31,000 acres burned
- 15 homes were destroyed or damaged and 24 buildings were destroyed or damaged



Bobcat Fire

- September 6, 2020 December 18, 2020 Bobcat fire burned within the San Gabriel Mountains and the Angeles National Forest
- One of largest fires on record in Los Angeles County
- Over 115,000 acres burned
- 87 homes were destroyed and 83 structures were destroyed



EXECUTIVE SUMMARY

BOBCAT AND LAKE FIRES COMMITTEE

As the Bobcat and Lake Fires approached full containment, on October 13, 2020, the County Board of Supervisors directed the Office of Emergency Management to activate the Recovery Section of the CEOC, and coordinate with County departments to take all necessary actions to effectuate the recovery phase for the impacted communities. The Recovery Section established a Bobcat and Lake Fires Committee as the first step to unify a coordinated approach. The Committee is a comprised of six task forces headed by agency directors and senior level managers. The Recovery Task Forces work in collaboration with the CEOC – Recovery Section throughout the entire length of the recovery process. This communication ensures that recovery efforts do not hinder or impact operational objectives and rebuilding efforts.

OBJECTIVES

- Conduct transitional planning from short-term actions that are currently underway, such as Local Assistance Center operations, to medium and long term recovery objectives.
- Develop medium-term and long-term recovery objectives and identify recovery program and services.
- Develop a comprehensive framework that supports the reconstitution and recovery efforts of the Bobcat and Lake Fires.

PURPOSE OF THE PLAN

The purpose of this plan is to set a path forward on how the County will recover from the Bobcat and Lake Wildfires and a strategic approach to achieve it. It capitalizes on our County's strengths, our partnerships and identifies the investments we need to keep Los Angeles County strong. The Plan is a foundational pillar and will be utilized for Recovery Management. It integrates recovery efforts County-wide and is informed by residents, community partners, County departments, and other jurisdictions within and outside the County.
